Drive Clean **Chicago**

- Incentive program for fleets & station providers in Chicago Area
- Achieves City's sustainability goals by helping fleets reduce and replace petroleum use
- Funded by Federal Congestion Mitigation and Air Quality Improvement Program grant

Drive Clean **Station**

How does the program work?

- Competitive grant program
- Apply by responding to Request for Applications
www.DriveCleanChicago.com
- Selection committee reviews and selects projects
- Grant agreement with CALSTART
- Funding released upon project completion & verification
- All stations must be complete by June 30, 2017

Drive Clean **Station**

Who can participate?

- Solicitation is open to all public, private and non-profit organizations
- Partnerships are allowed
- A single entity must act as lead respondent and overall project manager

Drive Clean **Station**

What technologies are eligible?

- CNG and DC Fast Charger Stations
- Projects must be located within 6-county Chicago area
- Stations must be public or shared-use
- Easily accessible

Drive Clean **Station**

CNG Stations

- Site must easily and safely accommodate all CNG vehicle types
- Must comply with NFPA Article 52- Standard for CNG Vehicular Systems
- Must comply with FMVSS 304
- Must Comply with ASME pressure vessel code...

Drive Clean **Station**

How much funding is available?

- Up to \$1,425,000 in grant funds
- Up to 30% of single station costs
 - Up to \$15,000 per DC Fast Charge station
 - Up to \$300,000 per CNG Station
- Eligible Costs
 - Site design, installation, labor, site prep, utility upgrades, signage, and equipment necessary to install the station
